FILMING NOTIFICATION 2nd Letter

Thursday 20th September 2018

Dear Resident /Business Owner,

August Street Films Ltd are currently in production of *Jack Ryan 2*, the follow up series to the hit Amazon television show. This is a glossy bond-style thriller based on the Tom Clancy character. A sequence of the new series will be shot on Irving Street, for three days ~ Monday 1st to Wednesday 3rd October ~ between the hours of 7am and 7pm each day. We aim to display this internationally recognisable and iconic central London location to a worldwide audience.

In this second letter of notification we would like to provide you with a more detailed breakdown of our activities. The majority of our filming will be centered around the Steak & Co restaurant at the end of Irving Street and will include interior and exterior shots. We will be simulating a gunshot and foot chase and be featuring actors dressed as police, use of crime scene tape and emergency vehicles. We are working with the Metropolitan Police Film Unit and, for this sequence, we will have the presence of uniformed real police officers to oversee our activities.

There will be intermittent traffic control on Irving Street and Orange Street for health and safety reasons over the three days. We are working with local businesses to ensure that the daily delivery process operates smoothly. Location marshals and production security will be on site to assist and ensure that Irving Street and Orange Street flow and are kept open for business.

For one day on Monday 1st October, we intend to use an aerial drone for a short part of the filming. The drone is permitted to fly by Westminster Council four times, for up to 15 minutes, between 1000-1200 on one day only. Our intention is to integrate our work with the normal daily operation of Irving Street and the surrounding area, hence the 1000-1200 slot – after deliveries and before the lunch rush.

The drone can only fly if the weather allows. If the weather is not good for us on Monday 1st we may attempt to fly on Tuesday 2nd or Wednesday 3rd October instead. For this one element, we will require a maximum of four 15 minute holds within the two hour window on one day. Extras will be used to populate the area during this period. The production would like to thank you for your support in our careful management of this, to ensure that we are able to meet all of our safety requirements whilst the drone is flying. This shot in particular will really add production value and exhibit Irving Street to a world audience.

We continue to liaise with Westminster City Council Filming & Events Office and the Heart of London Business Alliance with respect to all relevant permissions and procedures applicable to filming of this nature. During our three days of filming we will require essential vehicle parking in the local area (not on the Square itself) as per the map attached.

We would like to reassure residents that on all days, we will have stewards on site throughout the shoot to help wherever possible. We fully appreciate that filming on Irving Street and Orange Street is a privilege and your support is vital to achieving our filming, we would like to thank you in advance for your support. 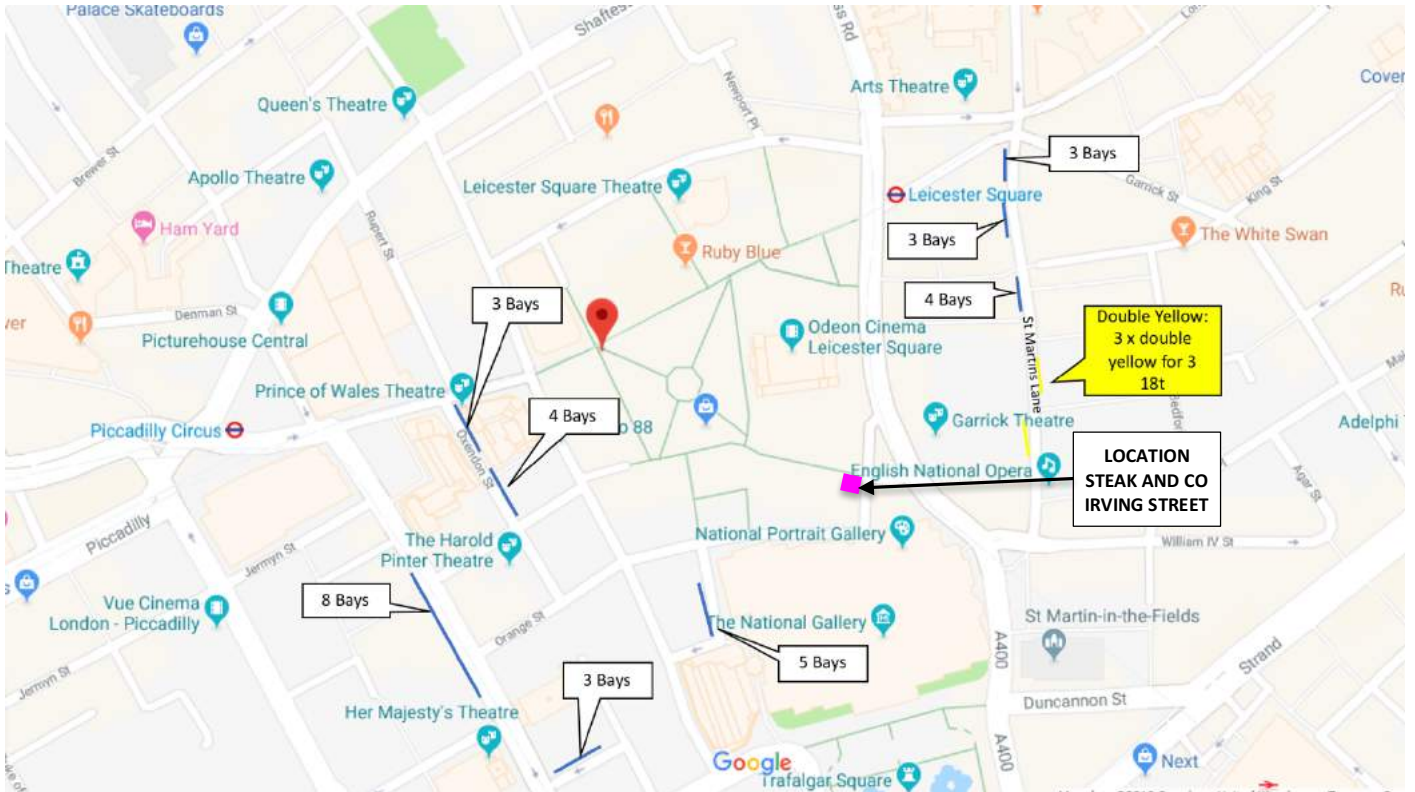
